

## Warranty Sample COLORPLUS®

Safal Steel (Pty) Ltd (herein after referred to as Safal Steel) warrants that **COLORPLUS® DURA (AZ150)** steel supplied to the roll former for fabrication from prime material, will have a life prior to perforation by weathering in the natural elements of 15 years from date of installation. Furthermore Safal Steel warrants the exterior paint system of the **COLORPLUS® DURA** steel will not flake or delaminate for a period equivalent to the warranty provided for perforation by weathering as outlined above, subject to a maximum period of 15 years, from the date of installation. However, normal weathering which includes natural reduction in paint gloss and a natural colour change of the paint finish is not covered by this warranty.

### Warranty is subject to the following terms and conditions:

- The product is an official **COLORPLUS® DURA** steel brand.
- The product is installed in strict accordance to the National Building Regulations of South Africa.
- The product is used within the parameters of the South African corrosive zones and the product selection guide found in the Safal Steel corporate brochure.
- All flashings, fasteners, or components fixed to or used with the product must be manufactured from materials approved by Safal Steel.
- The product as supplied, must not at any time come into contact or be coated with an incompatible material.
- Roofing must be washed at least once every 6 months with fresh water.
- The product must be maintained in accordance to Safal Steel's general guidelines.
- Additional coatings applied to the product will invalidate this warranty.
- Perforations or coating delamination partly or wholly due to the following causes are not covered by this warranty:
  - Defects attributed to faulty design, method of manufacture or installation of the product.
  - Mechanical, chemical, corrosion or other damage sustained during transport, handling, storage, erection or subsequent to erection.
  - Attack from chemical or other agents, fumes, liquids or solids other than direct rain or run-off falling onto the product.
  - Contact with soil, ash, fertilizer, moisture retaining substances, wet concrete, lead or copper and other dissimilar metals, chemical agents, liquid from copper flashings or copper pipes, green or wet timber or treated timber.
  - Failure to install the product in accordance to the National Building Regulations of South Africa or Safal Steel's general guidelines.
  - Failure to remove debris, swarf and or allow free drainage of water (including condensation) from all surfaces of the product.
  - Failure to replace corroded fasteners.
  - Corrosion arising within the lapped areas of end lapped sheets.
  - Installations subject to salt marine, severe industrial or unusually corrosive environments at any time in the future.
  - Accidental or intentional damage by a person or animal beyond reasonable control of Safal Steel.
  - Force Majeure.

### Subject to statutory obligations, under this warranty, Safal Steel's liability will be limited to Safal Steel's choice of one of the following options:

- Providing the same material in a quantity sufficient to replace the defective product.
- Providing the equivalent material in a quantity sufficient to replace the defective product.
- The cost of repairing the defective product.

### Safal Steel shall not be liable for the following:

- Labour costs associated with the removal or repair of the defective product, or installation of the replacement product.
- Injury to persons, damage to property, loss of income, profit or business or any other indirect loss arising from or caused in any way by the defective product.

Safal Steel extends this warranty solely to the roll former.

Safal Steel reserves the right to inspect a building prior to issuing of the warranty and/or to inspect and conduct tests as necessary at any time after a claim is made under this warranty.

The warranty is given in lieu of all other considerations or warranties expressed or implied except to the extent that any statute applicable to this contract prevents the exclusion restrictions or modifications of such conditions or warranties.
